NOTE This product can only be used when the license plate has been relocated as with Kuryakyn P/N 2098 or 2099.

TOOLS SUGGESTED

Set of hex wrenches, socket set and ratchet

PROCEDURE

STEP 1 Remove your license plate; set it aside for now.

STEP 2 Remove the two fasteners securing the stock license plate assembly to the rear bar; the assembly and fasteners will not be re-used. See PIC.1.

STEP 3 Hold the Rear Bar Accent in place and secure with the two included 5/16-18 x 3/4 BSCS. See PIC.2.

STEP 4 Tighten the fasteners.
